This Nomination package must be submitted by email to [dpliverman@hotmail.com](mailto:dpliverman@hotmail.com) no later than September 5, 2026 by 12 midnight, or by first class mail to Deborah Liverman, Nominations Chairperson, 1000 Cypress Chapel Road Suffolk Virginia 23434, **postmarked no later than Friday, August 29, 2025**. No responsibility for mail delivery shall be assumed by the Nominations Committee. No exceptions shall be made to the deadlines. If you are snail mailing, you are advised to send ASAP!

The nomination package should consist of **the above** form and up to two pages of narrative structured into five distinct paragraphs, each paragraph addressing one of the major categories outlined below. Additionally, a passport-style photo (a headshot with a neutral background and without sunglasses) must be included as an attachment or embedded in the two-page narrative.

**EMAIL document is preferred. You may submit your package in Microsoft Word (.docx) or Adobe (.pdf) or both. It will expedite any need for updates. Lastly, please ensure that a passport size photograph of your nominee is included with your nomination application. This will help to prevent any potential delays or rejections in processing your submission.**

The five categories to address in your narrative are:

1. The name of your nominee's primary home shag club membership, followed by details of any other club membership they hold, along with the number of years of membership for each.
2. Any offices your nominee has held within shag clubs or organizations, along with the years they held each position.
3. Any committee or projects your nominee has chaired and/or participated in, including the specific years of their involvement.
4. Your nominee's shag dance background. This should include their dance history, competitive dance experience, dance ability, engagement in sharing the dance with others, and their practice of dancing with multiple partners.
5. Any additional information you believe is relevant and supportive of this nomination.
